NOTICE OF RACE

Issued June 9, 2016

1. RULES

- 1.1. The regatta will be governed by the rules as defined in The Racing Rules of Sailing
- 1.2. The following documents shall apply:
 - 1.2.1. US Sailing Regulations 2, 10 and 13.
 - 1.2.2. The Conditions for the United States Junior Sailing Championships.
 - 1.2.3. The US Sailing Championship Support Vessel Policy.

 - 1.2.4. These Championships are not being conducted as a sanctioned or class association event. Only the Equipment Measurement Rules for the C420 and Laser Radial classes will apply. However, US Sailing encourages sailors to join their class Associations to support their efforts.
- 1.3. Racing Rules will be changed as follows:

Rule 29.1 and rule 30.1 are changed to permit the hailing of recall numbers. The failure of any boat to hear the hail, an untimely hail of OCS boats, failure to hail any boats, and the order of the boats in the hail shall not be grounds for granting redress;

the preamble to Part 4 and rule 40 are changed so that competitors shall wear a US Coast Guard (USCG) approved personal flotation device (PFD) while on the water other than for brief periods while adding or removing clothing. The PFD shall depend 100% on foam for flotation. No modifications of the PFD are permitted and it shall be the appropriate size for the sailor.

rule 60.1(a) is changed to prohibit a boat from protesting another boat for an alleged breach of any class rule other than class equipment measurement rules;

rule 61.1(a) is changed so that "A boat intending to protest about an incident that occurs in the racing area shall notify the Race Committee finish boat of her intention as soon as possible after finishing, including the boat identification number of the boat(s) being protested";

rule 64.1 is changed to allow penalties imposed by the Protest Committee, for hearings held under rule 60.3, as changed, which may range from a reprimand to a dismissal from the regatta;

rule 77 is changed such that a boat is not required to display national letters; however, competitors may be required to apply recall numbers to their boat or sail;

Appendix D5.2 is changed to substitute a yellow flag for signaling a breakdown on the boat. Reference to umpire is replaced with protest committee;

These changes will appear in full in the sailing instructions. The sailing instructions may also change other racing rules.

2. DISCIPLINES

- 2.1. A minimum of three (3) boats for the triplehanded (Sears) if applicable and five (5) boats for the other divisions are required **to race all races** unless there redress is granted. If not, the fleet will not be sailed. The regatta shall include the following disciplines utilizing the following class compliant equipment:
 - 2.1.1. Singlehanded Dinghy -- BYOB Laser Radial
 - 2.1.2. Doublehanded Dinghy -- BYOB Club 420 with Spinnaker, Trapeze and mainsheet bridle.

3. ELIGIBILITY

- 3.1. Competitors must have reached their 13th birthday but not their 19th birthday during the calendar year in which the event is held.
- 3.2. Competitors must be individual or family members of US Sailing at the time of their respective first qualification event.
- 3.3. All helms must be a member of a Local Sailing Organization (LSO)* that is a member of its Regional Sailing Association (RSA) and US Sailing.
- 3.4. For divisions other than singlehanded, other crew member(s) must be members of a LSO that is a member of US Sailing within the same RSA as the helm.
- 3.5. All the members of a crew shall reside in or regularly compete in the same RSA where the club is geographically located.
- 3.6. An alternate is named on the entry form at the first level of competition, and may not be changed in the competitive year. The alternate will attend the championship only if a crew member withdraws.

4. QUALIFICATION

- 4.1. A minimum of five (5) boats are required to be both entered by the NOR registration deadline and on the starting line for the single and doublehanded fleets in order for the winners to move on.
- 4.2. This Area will qualify two (2) teams for both the singlehanded and doublehanded disciplines.
- 4.3. A Team is defined as all contestants listed on the entry form for a specific LSO, except the alternate.
- 4.4. The skipper must remain the same throughout the series of qualifying events within and through his/her Area Qualifying event and including the National Championship. If the skipper is unable to continue, then the runner-up team will be named to replace the winning team.
- 4.5. A crew member may be substituted with the named alternate, with the approval of the Protest Committee, or if between events, by the next-level Protest Committee. Once so named, the alternate shall compete as a named member of the team for the rest of the competitive year. An alternate, once used, may not be replaced or substituted for, without the written permission of the next level Protest Committee prior to the event.

5. REGISTRATION and ENTRY

- 5.1. Registration may only be made by completing the online forms at:

- 5.2. Registrations shall be submitted on-line no later than midnight (EDT), July 13, 2016.
- 5.3. If requested by the Organizing Authority, an applicant shall send a copy of his or her birth certificate or passport to complete the application.
- 5.4. The entry fee is \$ 150 per competitor, which includes Breakfast and Lunch each day for competitors, a BBQ dinner on Saturday July 16, Tshirts and prizes.
- 5.5. The entry fee shall be paid by credit card online at the time of registration. Entry fees are non-refundable unless a boat is present at the regatta and a fleet is not sailed. (See NOR 2.1.)
- 5.6. A completed entry is defined as all forms having been completed on-line and all appropriate entry forms having been received by the host club one week prior to the event.
- 5.7. Late entries and/or changes may be accepted at the discretion of the regatta chairperson. To inquire about registering after the date listed above, contact the regatta chairperson. The entry fee for late entries is \$175 per sailor.
- 5.8. Limited Housing will be provided as detailed in NOR 18.1.

7. MEASUREMENT

Each boat shall comply with the equipment measurement rules of its class and may be inspected for compliance at any time during the regatta at the discretion of the Protest Committee.

8. SAILING INSTRUCTIONS

The sailing instructions will be available at registration.

9. VENUE

The regatta will be sailed in the Long Island Sound.

10. SCORING

10.1. The Low Point System of Appendix A will apply.

10.2. Three (3) races are required to be completed to constitute a series.

(a) When fewer than five (5) races have been completed, a boat's series score will be the total of her race scores.

(b) When five (5) or more races have been completed, a boat's series score will be the total of her race scores excluding her worst score.

11. PROTEST AND APPEALS

- 11.1. Decisions of the PC will be final as provided in rule 70.5. However, a decision following a hearing under rule 69.2(a) may be appealed.
- 11.2. Contact information provided at registration, including cell phone number for the helm of each boat entered will be provided to the chair of the PC and the PRO in the event of a protest.
- 11.3. Rule 65.2 **INFORMING THE PARTIES AND OTHERS** is changed as follows:
A *party* to the hearing is entitled to receive the above information in writing, provided she asks for it in writing and hand-delivers her request to a member of the protest committee no later than the protest time limit on the last day of racing or one hour after being informed of the decision, whichever is later. The committee shall then, within two hours, hand-deliver the information to the *party*, including when relevant, a diagram of the incident prepared or endorsed by the committee.
- 11.4. Rule 66 **REOPENING A HEARING** is changed as follows:
66.1 The protest committee may reopen a hearing when it decides that it may have made a significant error, or when significant new evidence becomes available within a reasonable time. A party to the hearing may ask for a reopening no later than 24 hours after being informed of the decision. When a hearing is reopened, a majority of the members of the protest committee shall, if possible, be members of the original protest committee and include at least one National Judge.
66.2 Area Qualifier Reopening
(a) A party to a hearing of a protest or request for redress may request an Area Qualifier Reopening. The request shall be in writing and include the significant error that the party believes the protest committee made or the nature of the significant new evidence within a reasonable time. The request shall be made no later than 24 hours after the hearing or 24 hours after the protest time limit on the last day of racing, whichever is later. The request, along with copies of the original protest or request for redress, the facts found, the decision of the protest committee, any new evidence that cannot be presented verbally, and e-mail and phone contact information for all parties to the hearing as well as the chairman of the protest committee, shall be sent by e-mail to the US Sailing Championships Director, LizWalker@ussailing.org and the US Sailing Championships Chair, swmadero@aol.com. The hearing shall be reopened when the foregoing information is received by the Director and the Chair.
(b) The protest committee for an Area Qualifier Reopening shall consist of the chairman of the original protest committee plus four certified judges appointed by US Sailing. A majority of the committee's members shall be National or International Judges. The Championship Chair will appoint its chairman.
(c) An Area Qualifier Reopening will be conducted by telephone/VOIP conference call. The time and date for the conference call shall be established by the chairman as soon as practicably possible and no later than seven days after the request for reopening is e-mailed. The chairman will e-mail to the parties to the hearing the request for reopening, the facts found, the decision of the protest committee, the time and date of the hearing, the process for joining the call and any other relevant documents.

12. SUPPORT & SPECTATOR BOATS

Spectator boats will not be provided. Private Spectator Boats shall stay well clear of the course area while the boats are racing and must listen to the VHF radio for updates and directions coming from the Race Committee.

13. COACHING

- 13.1. This is a Grade **3** Event as defined in the US Sailing Championship Support Vessel Policy. See <http://www.ussailing.org/racing/championships/coaching-and-support-boat-policy/>. A private coach is defined as any coach NOT hired by US Sailing.
- 13.2. Except as provided in the Policy specified above, instructors, coaches and other support personnel and family members shall not go afloat in the defined racing area at any time during the clinic or racing days, except in spectator boats as defined in NOR 12.

13.3. Outside contact with competitors is prohibited on racing days commencing with the competitor's arrival at the host club and shall continue until released by the Protest Committee on racing days.

13.4. Outside contact is defined as a parent, family member, spectator, or coach. Competitors shall not receive advice, instruction, or any type of outside assistance (other than that provided by US Sailing) including electronic communication devices while at the sailing venue during racing days. It is the intent of this rule to prohibit contact between competitors and any person, who, in the opinion of the Protest Committee, is a coach, instructor or advisor.

13.5. The Protest Committee may protest and disqualify a competitor for breaking the rules of NOR 13 from all races on the day of the infringement

14. PERSONAL FLOATATION DEVICES (PFD) AND PERSONAL EQUIPMENT

14.1. Competitors shall wear a US Coast Guard (USCG) approved personal flotation device (PFD) while on the water other than for brief periods while adding or removing clothing. The PFD shall depend 100% on foam for flotation and be the appropriate size for the sailor (US Sailing Regulation 10). The PFD must be worn outside of all clothing except that a thin shirt may be worn over the PFD to prevent snagging. These will be checked at registration.

14.2. The only gear, rigging, or equipment that a team may take aboard a boat shall be - magnetic card compass, flags, plastic bucket or bailer, normally equipped ditty-bag, personal effects, including PFDs and protective clothing. For the events using the C420, competitors are required to bring their own trapeze harnesses.

14.3. Electronic fluxgate compasses and GPS devices of all varieties, styles and combinations are specifically banned.

15. PROHIBITED SUBSTANCES

15.1. For Junior and Youth events or for junior or youth competitors in any US Sailing championship, no participant or competitor shall use, either on or off the water: marijuana or any other controlled substance or alcoholic beverages as defined by state and federal law.

15.2. An alleged breach of this requirement shall not be grounds for a protest. However, when the protest committee believes that a competitor may have breached the above requirement, it shall follow the process described in the US Sailing Championships' Code of Conduct. See Appendix A.

16. CONDUCT OF COMPETITORS

16.1. All competitors are expected to maintain the highest levels of conduct throughout the entire event. Enforcement of discipline and conduct shall be conducted per rule 69.2(a) and the policies and procedures of US Sailing (Regulation 10 and 15.01)

16.2. The curfew of the competitors shall be 2100.

16.3. When the Protest Committee believes that a competitor may have breached the above requirement, it shall follow the process described in racing rule 69.2 and a competitor found to have breached this requirement shall be excluded from the remaining races of the series and, where practicable, removed from the regatta venue and sent home. The competitor's boat shall be disqualified from all races of the series.

17. PRIZES

17.1. The top finishing, eligible team(s) will qualify for US Sailing's Chubb U.S. Junior Sailing Championships. Registration may only be made by completing the online forms at:

17.2. Registrations shall be submitted online **by June 15 or within three days of qualification** whichever is closer to the event on the event website unless permission is granted by US Sailing's Junior Championship Chair.



18. HOUSING, MEALS AND LOCAL TRANSPORTATION

- 18.1. Housing will be provided for up to 40 sailors coming from clubs on Long Island or from more than 50 miles from American Yacht Club, for the nights of Friday July 15 and Saturday July 16. Housing will be allocated on a first-come, first-served basis and will require submission of a housing form at the time of registration.
- 18.2. Assigned housing must be used. All housed contestants must be at their host's house by 2100 hours each night. Failure to use assigned housing or to meet the curfew may result in the competitor being protested as per NOR 16.3.
- 18.3. Breakfast will be provided by the club. On the water lunch will be provided by the club. Dinner will be provided by the club after racing concludes on Saturday, July 16, 2016.
- 18.4. All competitors being housed are required to transport to and from American YC with their host family during the regatta July 16-17. This includes competitors who drive their own cars to the regatta. Competitors who drive their own cars to the regatta will be required to leave their cars at the club and transport with their host families.

APPENDIX A Championship Code of Conduct

Introduction

Each competitor in a US Sailing Championship or Qualifier hereby pledges to uphold the spirit of this US Sailing Code of Conduct (Code). This Code is not intended to establish a set of rules that will, by inclusion or exclusion, prescribe the appropriate behavior for competitors in every aspect of their participation in a Championship or Qualifier. Rather, the Code offers general principles to guide the conduct of competitors in situations that have ethical implications.

The competitor commits to familiarization with this Code and understands that acceptance of its provisions is a condition of participation in a US Sailing Championship or Qualifier. Competitors who do not conform to this Code will be subject to the consequences of their actions, as specified below. The competitor has a right to a hearing if charged with a violation of this Code.

Elements of the Code

Each competitor in a US Sailing Championship pledges they:

Participation

> Will abide by *The Racing Rules of Sailing*, the US Sailing Regulations, all rules related to the Championship selection procedures as specified by US Sailing, the Championship Conditions, the Notice of Race and the Sailing Instructions for the Championship or Qualifier.

> Are eligible to compete under all US Sailing rules.

Fair Play and Conduct

Will abide by Rules 2 and 69 of the *Racing Rules of Sailing*.

Drugs & Alcohol

> Will abide by US Sailing Regulation 10.01.C for Prohibited Substances as defined below:

> For adult US Sailing championship events, no competitor shall use, either on or off the water: marijuana or any other controlled substance as defined by state or federal law.

> For Junior and Youth events or for junior or youth competitors in any US Sailing championship, no participant or competitor shall use, either on or off the water, marijuana or any other controlled substance, or alcoholic beverages as defined by state or federal law.

Sexual Abuse & Harassment

Will abide by US Sailing Regulation 13.04 for Sexual Abuse & Harassment.

Physical Abuse & Assault

Will abide by US Sailing Regulation 13.05 for Physical Abuse & Assault

Bullying & Hazing

Will abide by US Sailing Regulation 13.06 for Bullying & Hazing.

Enforcement of the Code

> Compliance with this Code depends primarily upon understanding and voluntary compliance, secondarily upon reinforcement by peers, and, when necessary, upon enforcement through disciplinary action.

> If a competitor has been alleged to have violated this Code, the competitor will be given two options:

- A) Voluntarily withdraw from the Championship or Qualifier where the violation occurred. The competitor shall be scored RET in all races sailed and not sailed. A report will be sent to US Sailing. If the offense warrants, further action will be taken pursuant to Rule 69

or

- B) A hearing will be held and if the Code is determined to have been broken, the hearing panel has the authority to remove the athlete from the venue immediately and mark all races as DSQ. Further action may be taken if needed pursuant to Rule 69.
- C) Before making a decision whether to withdraw from the Championship or Qualifier, or to request a hearing, the competitor will be given the opportunity to consult with an individual of their choice before racing commences, in order to better understand their options and potential outcomes.
